REQUIREMENTS:

- ii. The "word" Pre-qualification for each category shall be clearly written/marked on each envelope.
- iii. Firm/vendor must have at least 3 years' experience in the relevant field (Documentary proof to be provided
- iv. Company/Firm profile must show year of establishment (evidence to be attached)
- v. Detail of capability/capacity with respect to **supply, installation & Maintenance experience** and after sale service should be provided.
- vi. Detail of similar works completed in Banks/other organizations, along with documentary proof to be furnished.
- vii. Financial position of Firm/vendor with evidence of turnover in bank account for past one year to be furnished. Please attach certificate of the concerned Bank/organization.

- viii. Copy of Income Tax certificate/National Tax Number (NTN), General sales Tax (GST) Registration Certificate to be provided.
- ix. List of organizations whom supply of goods & services made during past 03 years to be included.
- x. Affidavit that the company/firm is not blacklisted by any Government, Semi Government, national or international organization and no case is registered against the firm/vendor in any court of law to be furnished.
- xi. Details of most recent 03 work orders completed to be furnished I along with documented proof with certificates of satisfactory services (Only those certificates will be considered which bear name and contact # of authorized officer).
- xii. Rates quoted must be valid for 120 days for submission of quotation.
- xiii. Audited accounts for firms for the last 3 years to be furnished.
- xiv. List of existing clients and list of projects in hand to be furnished.
- xv. A non-refundable Demand Draft/Pay Order of Rs.1,000/- in favor of Bank of Azad Jammu & Kashmir (BAJK) to be accompanied with submission of pre-qualification request.

xvi. Bank will not be responsible for any cost incurred in submission of pre-qualification documents.

Sealed Application (s) completed in all respects showing Expression of Interest separately for each category should reach on the address given below latest by 21st July 2017.
